TEBEKA at AIPAC

Executive Director Fentahun Assefa-Dawit participated in the 2017 AIPAC Conference. Fentahun was commissioned by The Israel Project (TIP), a non-partisan American NGO dedicated to informing the media and public discourse about Israel and the Middle East, to speak about the challenges of the Ethiopian community and Tebeka's work to 20/20 Leaders of America. This bipartisan group is comprised of African-American mayors, state departments, prosecutors, defense lawyers, political strategists, community leaders, police, and other law enforcement personnel to fundamentally change the way the American political system deal with issues of criminal law.

Demas Fekada- Filing charges against the cop

Demas Fekada and Tebeka petitioned the High Court of Justice against the decision of the former Attorney General, Yehuda Weinstein, to close the case file against the policemen who beat up Officer Fekada in April 2015. The current Attorney General, Avichai Mandelbilt, decided to reopen the case file. Tebeka strongly supports the

particularly against Ethiopians, is unacceptable. Following the reopening of the case, Tomer Marcia, Director of Tebeka's Legal Department reassured that, "Tebeka is working day and night to combat the phenomenon of racism and violence. The court's decision today has a large influence on the conduct of the police and public trust in the judicial system."

Since January 2017, Tebeka has handled 380 references. The cases include:

 The Ethiopian population was referred to in a negative light in a school textbook. The book was disqualified from being used after a letter was sent to the Minister of Education.

Racism Conference in the Knesset

Tebeka played a major role during the Knesset's (Israeli Parliament) day dedicated to combating racism. Tebeka collaborated with partners to create changes on the topic of, ""Racism Against Children and Youth: Law Enforcement and Education." Through meetings with Knesset members, planning with partners, and advocating for the rights of the undeserved, Tebeka continued to forge a path for a more equitable, fair society. Additionally, a report was prepared for the day which provided recommendations on this topic. The Knesset accepted the list of recommendations.
